ORDINANCE NO. 2, SERIES 1982

AN ORDINANCE RELATING TO THE GRANTING OF A FRANCHISE TO CONSTRUCT, MAINTAIN, AND OPERATE A COMMUNITY ANTENNA TELEVISION SYSTEM WITHIN THE CITY OF RIVER BLUFF, KENTUCKY

WHEREAS, the City of River Bluff has created a franchise to construct, operate and maintain a Community Antenna Television (CATV) System within the City of River Bluff pursuant to the Constitution and Statutes of the Commonwealth of Kentucky and the provisions of Ordinance No. 1, Series 1982, and

WHEREAS, the City Commission has examined and considered all applications for such a franchise and has heard and reviewed the presentations and the proposals of the public hearing of the City Commission, and

WHEREAS, the City Commission has found and does hereby find that Storer Communications of Jefferson County, Inc. (hereinafter referred to as Storer) is the applicant presenting the best legal, character, financial, technical and other qualifications, including the qualifications referred to in said Ordinance 1, Series 1982, and

WHEREAS, the City Commission has found that an award of the City of River Bluff CATV Franchise to Storer is in the best interests of the citizens and residents of the City of River Bluff; and

WHEREAS, the City Commission further determines that the bid of Storer is the best bid obtained, and

WHEREAS, all legal requirements for the award of this franchise have been fulfilled including but not limited to the due advertisement and receipt of bids therefore which have been opened publicly, now, therefore,

BE IT ORDAINED BY THE CITY COMMISSION OF THE CITY OF RIVER BLUFF, KENTUCKY AS FOLLOWS:

Section 1. The City of River Bluff does hereby grant and award a franchise to construct, operate and maintain a Community Antenna Television (CATV) System within the City of River Bluff pursuant to the authority and the provisions of Ordinance No. 1, Series 1982, to Storer.

Section 2. The grant and award of franchise as set forth in Section 1 of this Ordinance is conditioned upon full compliance by Storer with all provisions of Ordinance No. 1, Series 1982, and with all bid documents of Storer and with all other applicable provisions of law, provided, however, that in the event the higher degree of performance is more restrictive, or is more beneficial to the City, the provisions of said Ordinance shall apply.

Section 3. Storer shall reimburse the City of River Bluff for the cost of publication of Ordinance No. 1, Series 1982, and this Ordinance, together with incidental expenses including reasonable attorneys fees.

Section 4. This Ordinance shall take effect upon its passage, approval and publication as required by law.
