Oldham County Police Report

Officer Ernst discussed current trends they are seeing in the area. At this time, residents in Oldham County are locking vehicles and as a result, the criminal activity surrounding thefts from unlocked vehicles is not a threat at the moment.

Questions/Comments from Residents

Resident Phil Heard addressed the Board regarding an ongoing issue with a sewage pump located in Scott Karr's front yard. He noted that the problem has persisted for approximately five years, with multiple unsuccessful repair attempts during that time. Discussion followed regarding potential public health risks, possible system-wide failures, and the broader impact on surrounding properties.

Mayor Dillon provided background information on the sewage facility's ownership, historical capacity concerns, and recent efforts undertaken by himself and Katie Buhts to address the issue. In the coming days, Ms. Buhts will contact the County Engineer for a follow-up discussion regarding the sewage concerns. The City will inquire about the feasibility of conducting a third-party line test, as well as soil and water testing. While the sewage facility is privately owned and the City does not hold ownership of the associated easements, pipes, or the facility itself, the City will continue to coordinate with Bluegrass Water and relevant government agencies to assist in resolving the matter.

<u>Treasurer's Report</u> Accepted as presented. Katie Buhts updated the board that the fiscal year ending 6/30/2025 report was filed with the Dept. of Local Government this month.

<u>Drainage</u> Tom Sheffer provided an update on the recent culvert jetting project at the Ohara drainage easement. He coordinated with Temple & Temple to address several drainage concerns throughout the city. The culvert connecting the Ohara and Hacker properties remains blocked by roots that require removal. Mr. Sheffer will obtain an estimate from Temple & Temple for the root removal and present it to the Board for approval.

<u>New Residents</u> Paulette Bryant provided an update on several properties in the City that are pending, for sale and awaiting new residents. At this time, no action is needed.
